




Worldwide Regulated Open-End Fund Assets and Flows

Trends in the Second Quarter of 2023





Worldwide regulated open-end fund assets increased by 3.2% in euro terms to EUR 64.43 trillion in Q2 2023.¹ Worldwide investment funds registered net inflows of EUR 424 billion, down from EUR 631 billion in Q1 2023.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars increased to USD 70 trillion at the end of Q2 2023; this represented a 3.2% rise from the previous quarter. The following two graphs compare the net asset growth in the seven largest countries/regions.

On a euro-denominated basis, global equity fund assets surged by 4.7%, reaching EUR 28 trillion at the end of Q2 2023. Bond fund assets also saw an increase of 2.1% to EUR 11.7 trillion. Multi-asset funds experienced a 1% growth, reaching EUR 10.1 trillion, and money market funds (MMFs) advanced by 2.8% to reach EUR 8.9 trillion. Every fund category enjoyed an increase in net assets during the second quarter.




At the end of Q2 2023, 43.4% of worldwide regulated open-end fund net assets were held in equity funds. The share of bond funds amounted to 18.2% and the asset share of multi-asset funds was 15.7%. MMF assets represented 13.9% of the worldwide total.

(By type of fund, 2023:Q2)**




Looking at the worldwide distribution of investment fund net assets at the end of Q2 2023, the United States held the largest share in the world market, with 49.4%. Europe followed in second place, with its market share slightly decreasing to 29.9%. China (4.7%), Australia (3.5%), Brazil (3.5%), Canada (3.2%), Japan (3%), Republic of Korea (1%), India (0.8%), and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 8.1% of worldwide investment fund assets), Ireland (5.9%), Germany (4%), France (3.4%), and the United Kingdom (2.9%).



Net sales of worldwide regulated open-end funds registered net inflows of EUR 424 billion, down from EUR 631 billion in Q1 2023. Long-term funds recorded net inflows of EUR 149 billion, compared to EUR 123 billion in Q1 2023. Net inflows of MMFs amounted to EUR 275 billion, down from EUR 507 billion in Q1 2023.



Globally, equity funds recorded net outflows of EUR 27 billion, compared to net inflows of EUR 5 billion in Q1 2023. In contrast, bond funds maintained their positive trajectory, attracting net inflows of EUR 208 billion, up from EUR 137 billion in the previous quarter. Meanwhile, multi-asset funds sustained net outflows of EUR 80 billion, marking the fifth consecutive quarter of negative net sales.



During Q2 2023, the United States registered net inflows of EUR 234 billion, a decline from EUR 461 billion in Q1 2023.

The Asia-Pacific region² experienced net inflows of EUR 195 billion, compared to EUR 87 billion in Q1 2023. China's regulated open-end funds recorded net sales of EUR 161 billion, while India attracted net inflows of EUR 21 billion.

Europe experienced net inflows of EUR 10 billion, mainly led by positive net sales in Ireland (EUR 10 billion), Germany (EUR 7 billion), France (EUR 7 billion), and Switzerland (EUR 7 billion). In contrast, Luxembourg recorded the largest net outflows (EUR 26 billion), followed by the Netherlands (EUR 8 billion) and the UK (EUR 5 billion).

The Americas³ were the only region to report negative sales in Q2, with net outflows amounting to EUR 14 billion. Brazil reported net outflows of EUR 24 billion, while Mexico experienced net inflows of EUR 6 billion.



European long-term funds saw a decline in net inflows, from EUR 62 billion in Q1 2023 to EUR 1 billion. Equity funds recorded net outflows of EUR 31 billion, compared to net inflows of EUR 15 billion in Q1 2023. Multi-asset funds continued to record net outflows (EUR 33 billion compared to EUR 9 billion in Q1). On the other hand, net sales of bond funds remained positive at EUR 44 billion, but at a level slightly below the EUR 52 billion observed in Q1 2023.


MMFs continued to experience net inflows, totalling EUR 8 billion in Q2 2023, down from EUR 11 billion in Q1 2023.

In the United States, long-term open-end funds registered net inflows of EUR 64 billion, compared to EUR 56 billion in Q1 2023. This outcome reflected a decline in the net inflows recorded by bond funds, from EUR 96 billion in Q1 2023 to EUR 88 billion, and by an increase in the net outflows recorded by multi-asset funds, from EUR 0.4 billion in Q1 2023 to EUR 12 billion in Q2. On the other hand, equity funds continued to record net outflows (EUR 11 billion), albeit less significant than in Q1 (EUR 39 billion).

MMFs in the United States attracted net inflows of EUR 170 billion, down from EUR 405 billion in Q1 2023.
