




Highlights of Developments in Q2 2020

- Net assets of UCITS and AIFs bounced back strongly, crossing the EUR 17 trillion threshold again.** UCITS net assets increased by 11.2%, whereas the net assets of AIFs grew by 5.7%. The strong recovery of global stock markets and the higher share of equity in the asset allocation of UCITS compared to AIFs, combined with the exceptionally high net sales of UCITS, explain these differences in growth rates.
- Net sales UCITS rose to EUR 272 billion, a level not seen since Q1 2015.** Net sales of AIFs, on the other hand, dropped from EUR 51 billion in Q1 2020 to EUR 1 billion in Q2 2020.









- All main categories of long-term funds recorded net inflows, thanks to the sharp rebound in the net sales of long-term UCITS funds.** Net sales of UCITS bond and equity funds recovered strongly, as investors reacted positively to the substantial monetary and fiscal stimulus packages adopted across the globe and the easing of lockdown measures. By contrast, AIF equity, bond and multi-asset funds recorded net outflows, which may be partially explained by the potential implications of Covid-19 for the insurance sector and pension funds, which suffer from a lower capability to contribute to retirement savings plans by individuals and employers.
- Money market funds attracted EUR 136 billion in net new money, the largest inflow ever observed on a quarterly basis.** These high net inflows indicate that many investors still took a wait-and-see attitude during Q2 2020, not knowing how the Covid-19 pandemic will further impact the world economy.


Net Sales of AIFs by Investment Type²


Net Assets of UCITS and AIFs by Investment Type³





Ownership of Investment Funds in Europe ⁴


**Investment Fund Ownership by Type of Investor
(EUR billions and share of total, end Q1 2020)**




**Investment Fund Ownership by Country
